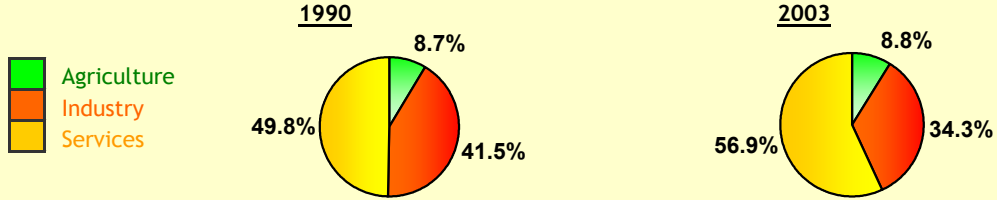

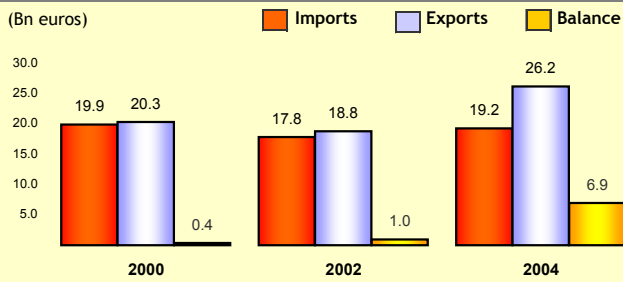

GDP BY SECTOR

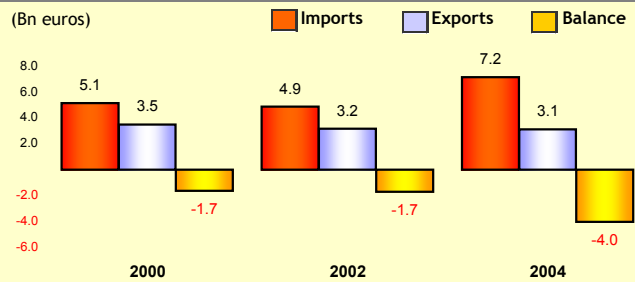

EU25 MERCHANDISE TRADE WITH CHILE

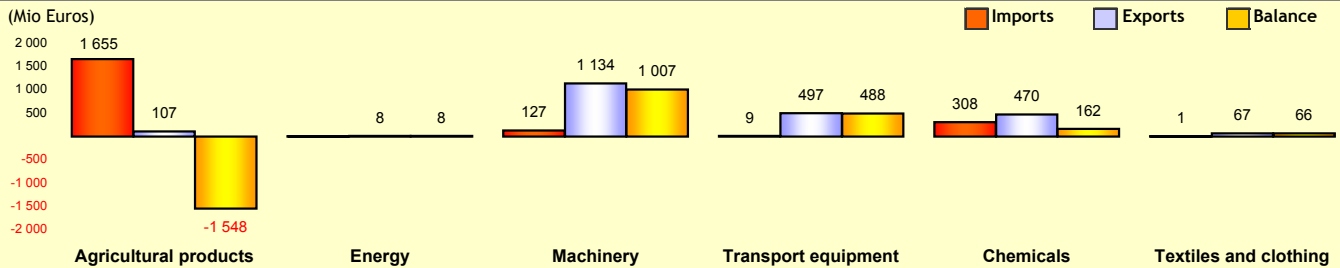

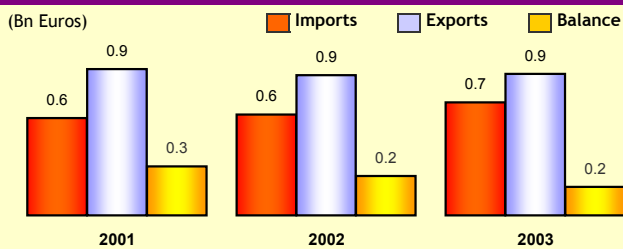

EU25 MERCHANDISE TRADE WITH CHILE BY PRODUCT (2004)



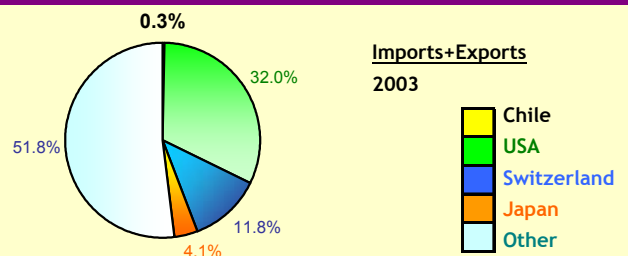

EU15 TRADE IN SERVICES WITH CHILE

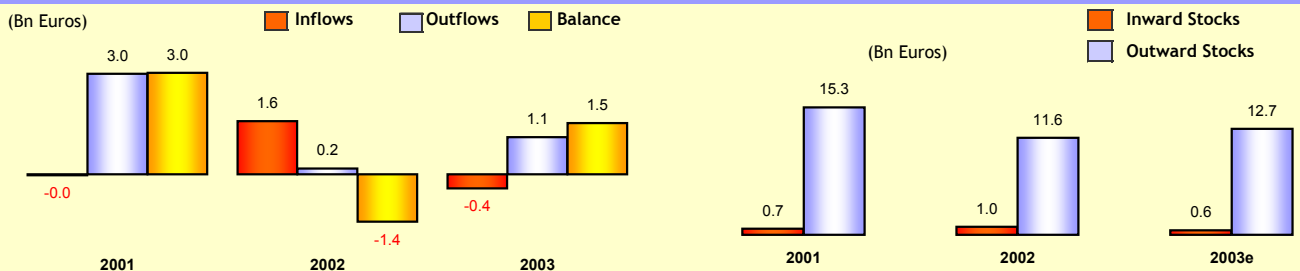

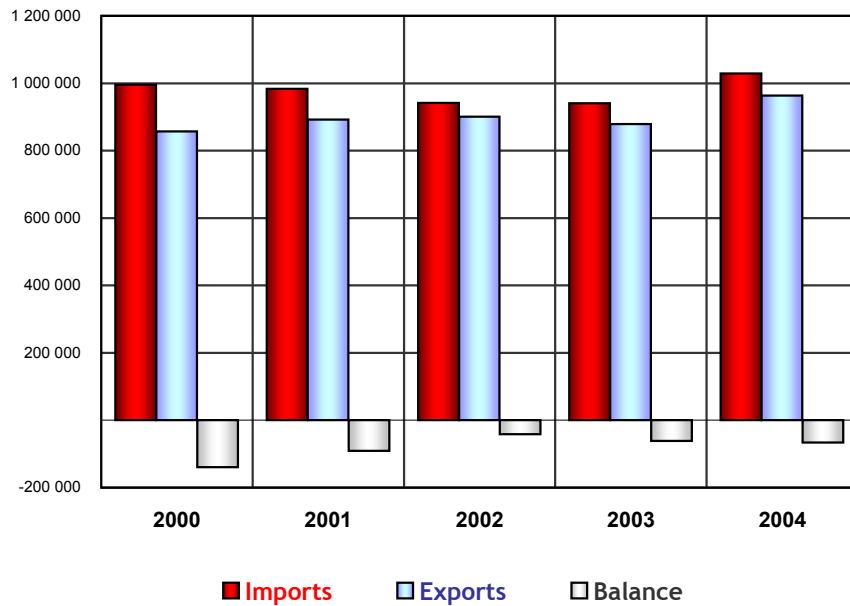

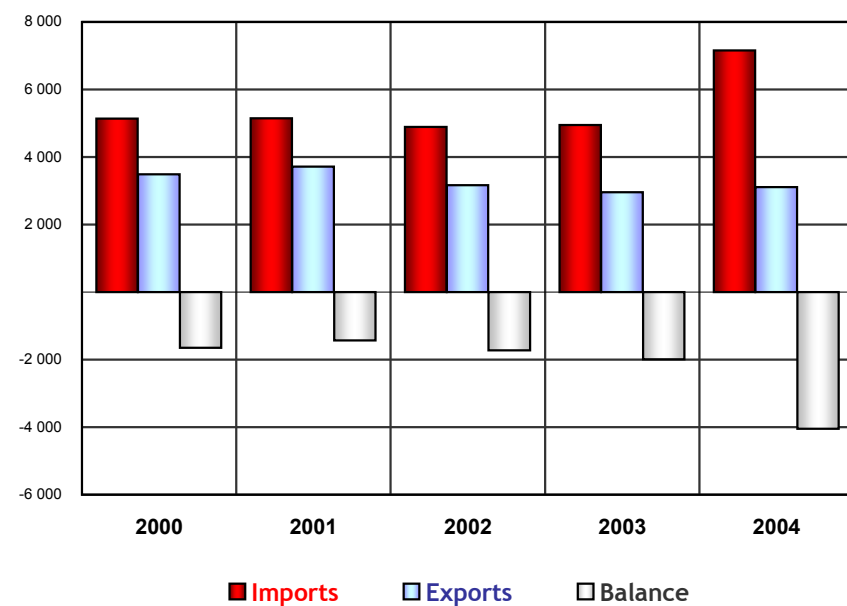

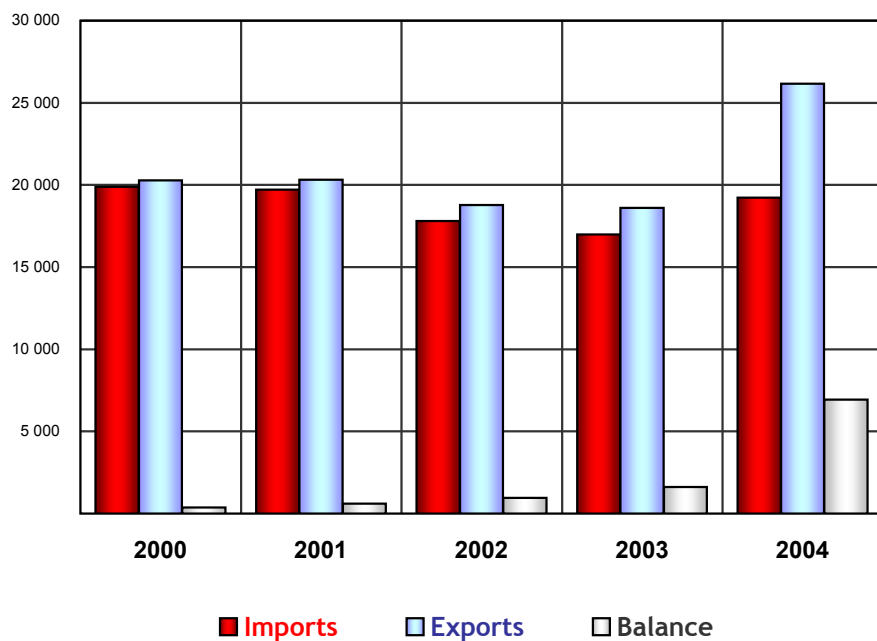

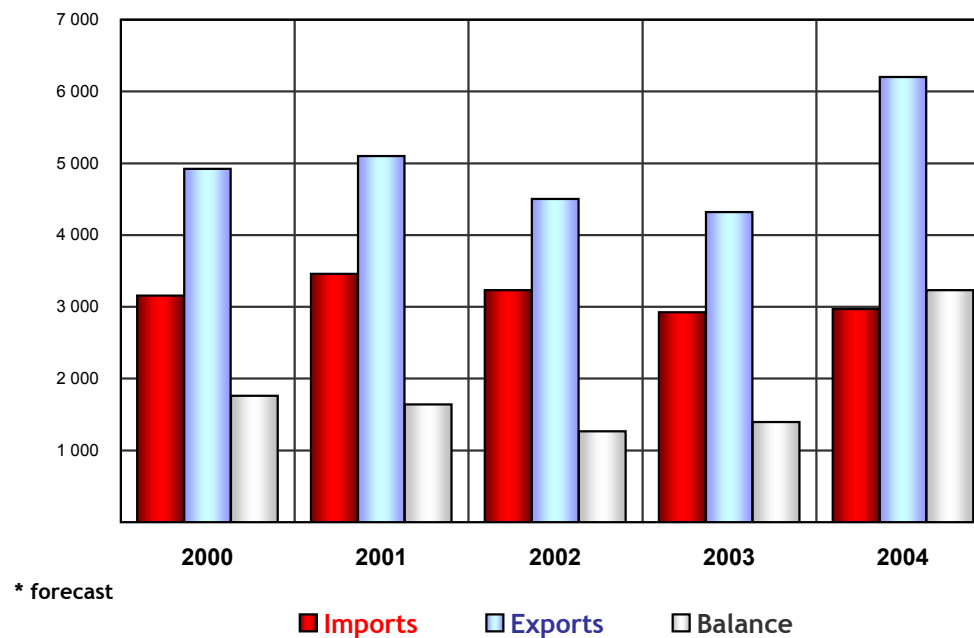

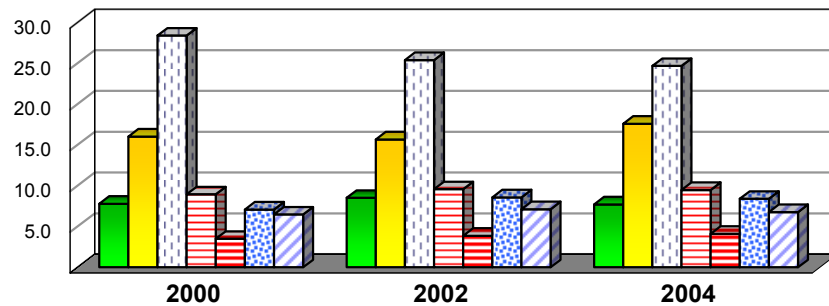

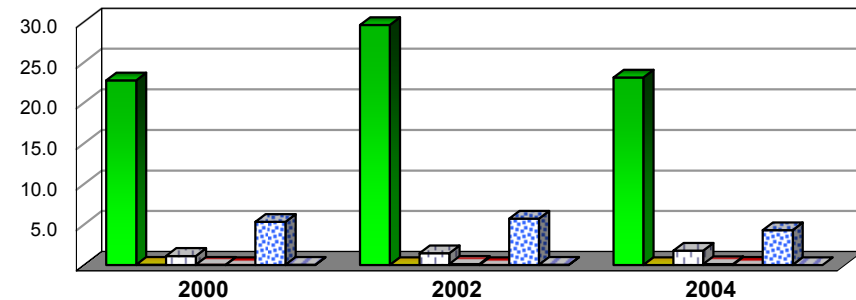
Structure of Imports (%)

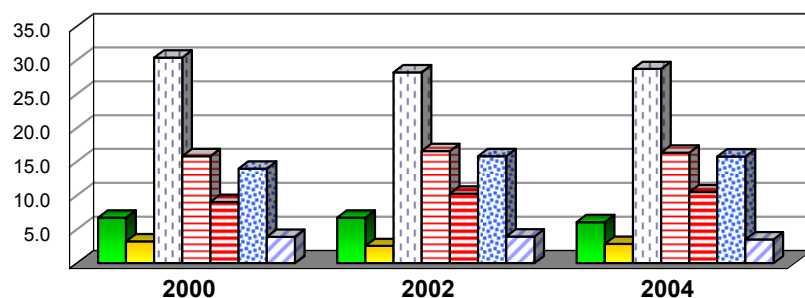

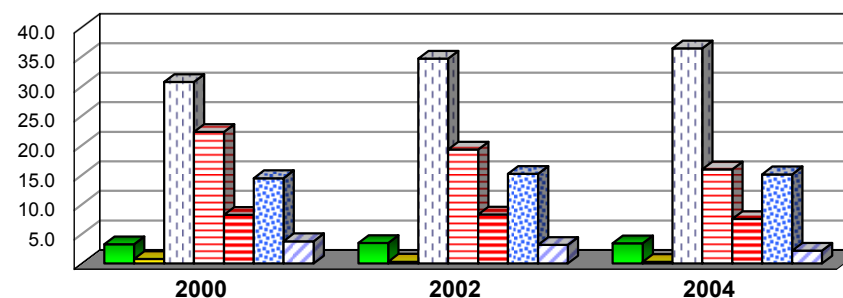

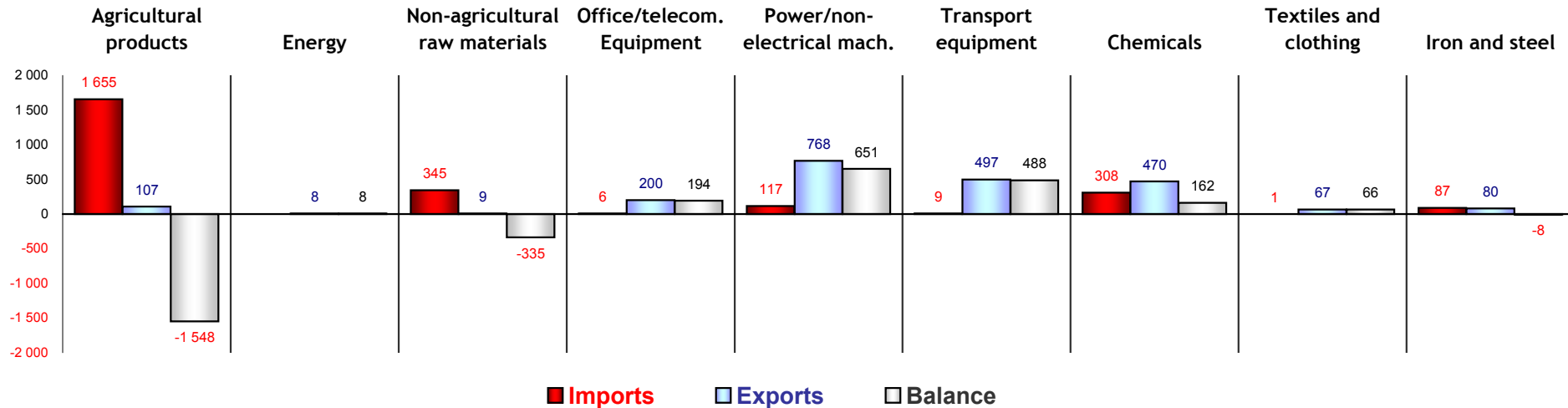
