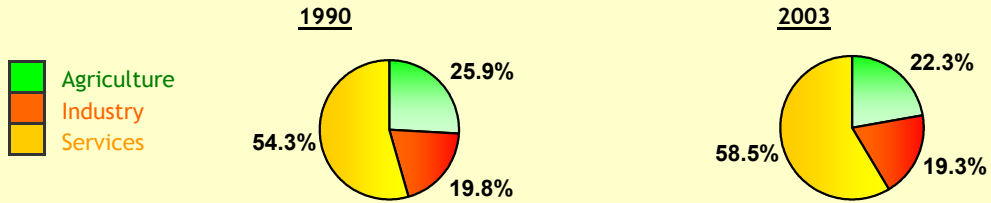

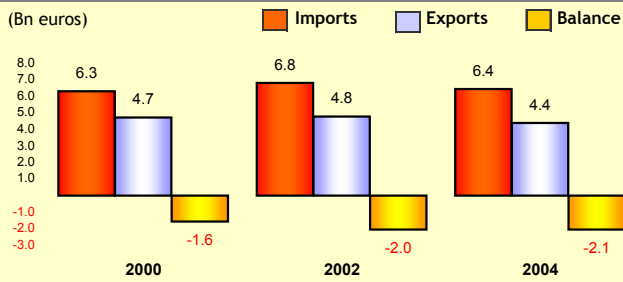

GDP BY SECTOR



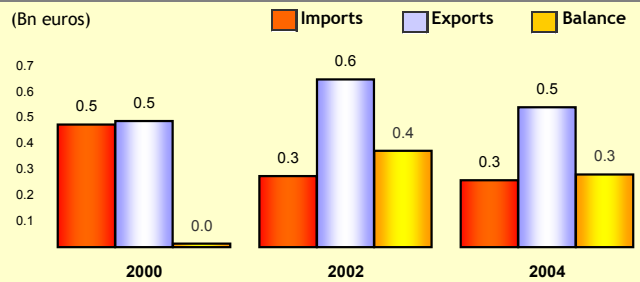

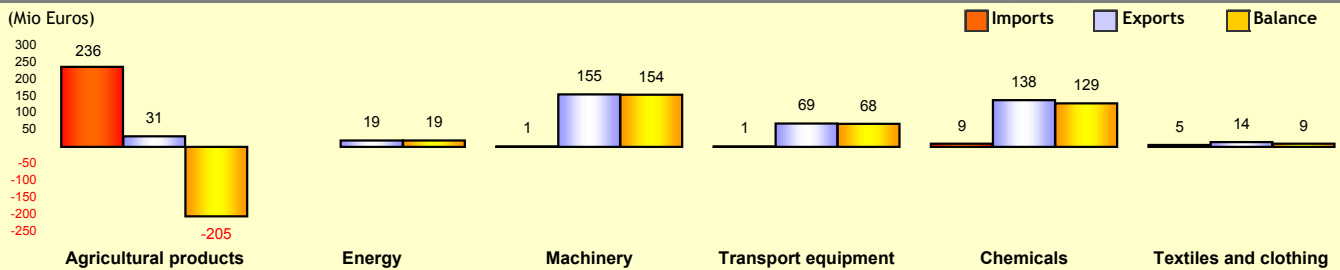
EU25 MERCHANDISE TRADE WITH GUATEMALA

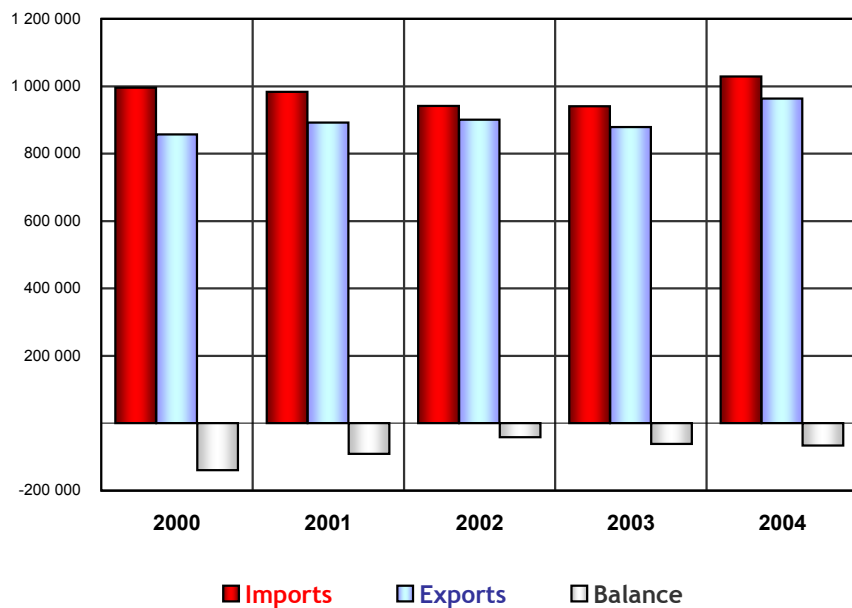

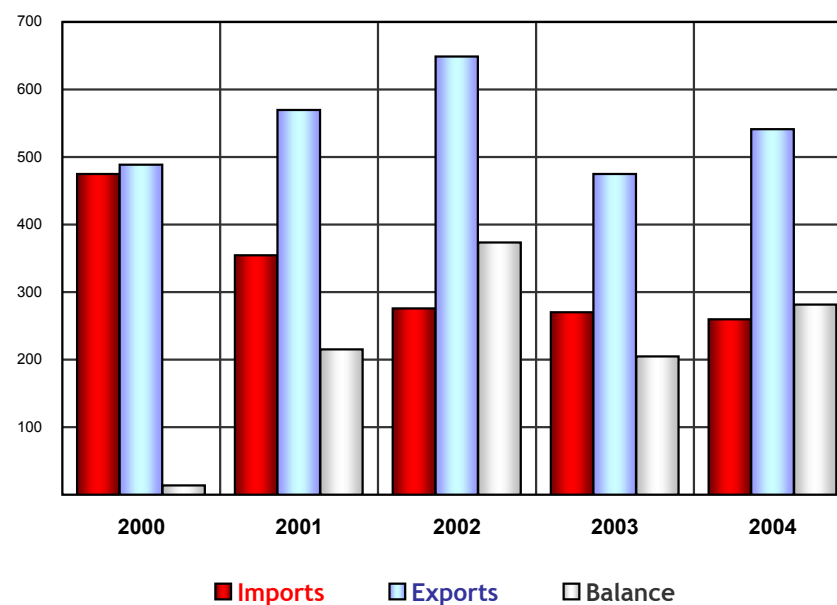

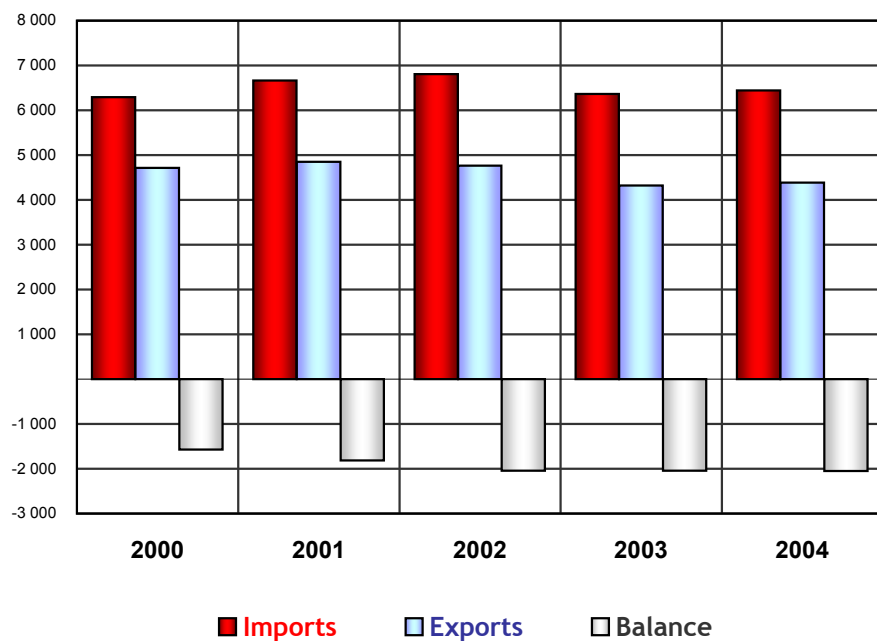

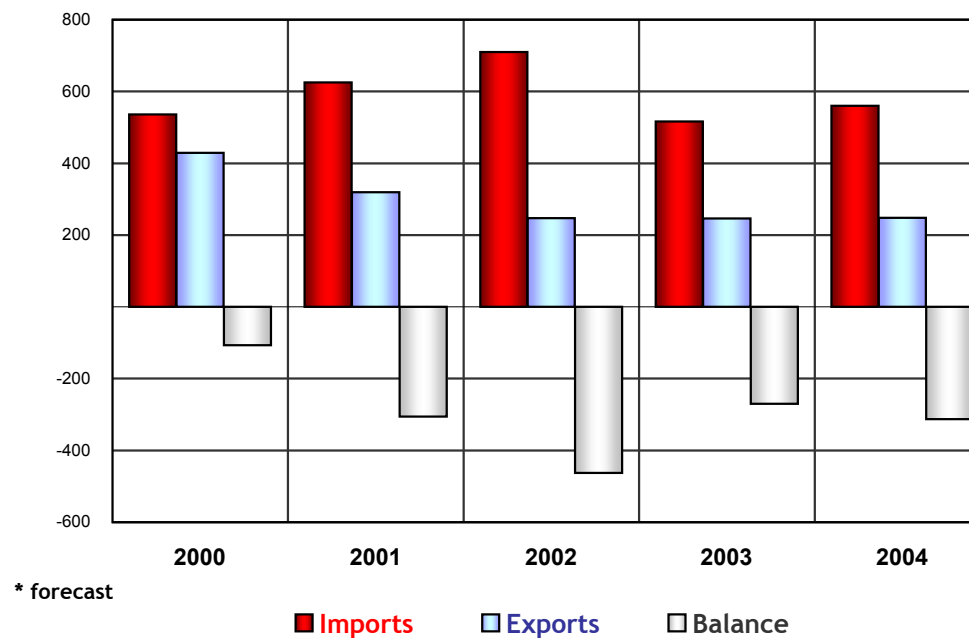

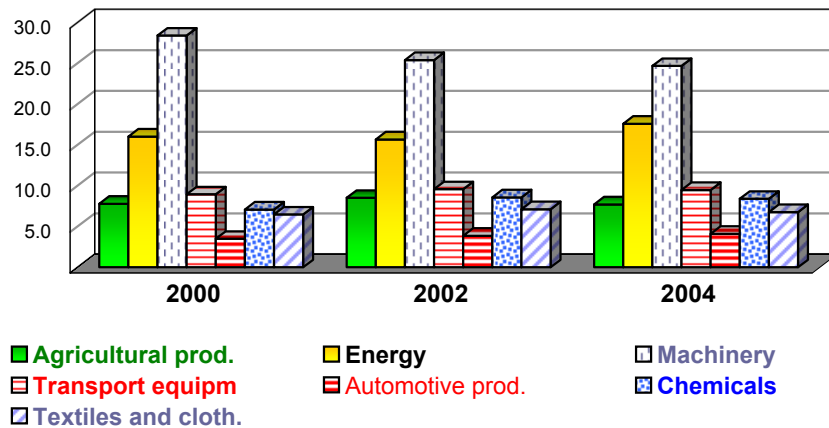

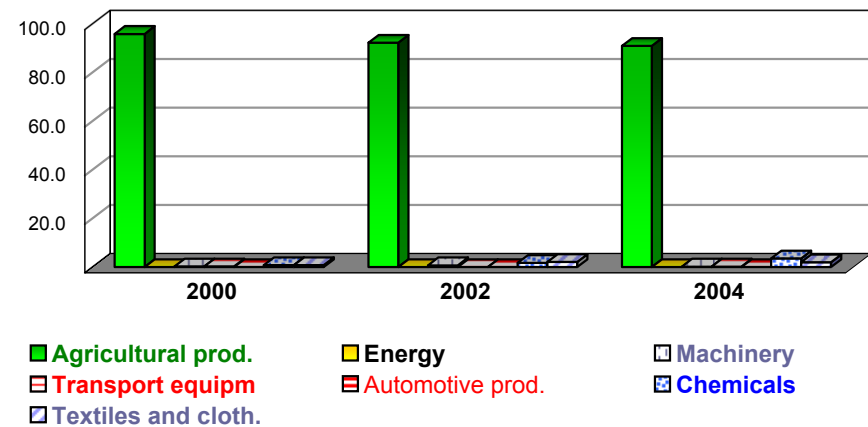

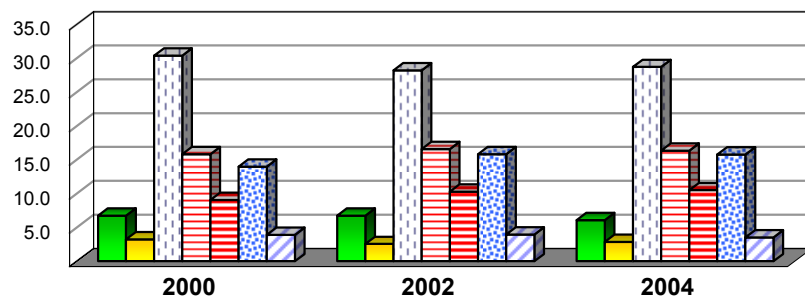

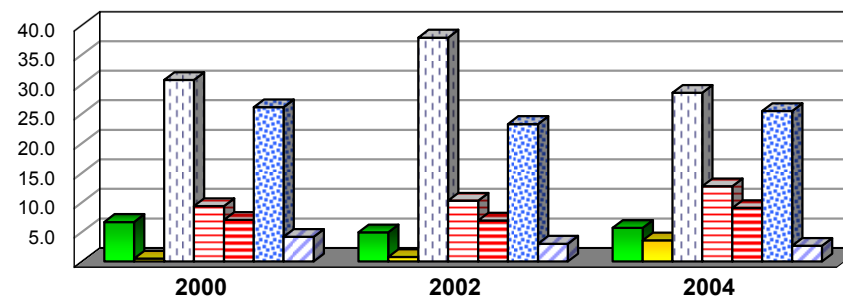

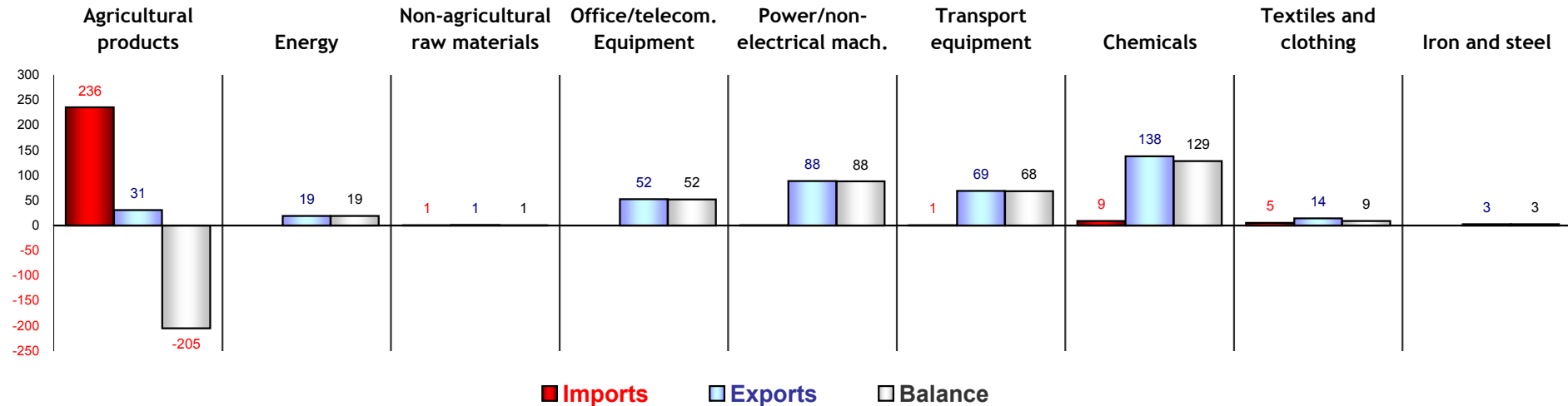
